Dear Edin Omanovic

Thank you for your email of 24 April 2014 in which you requested the following information relating to export licences (I quote):

I would like to make a FOI request about a specific classification. In a 2011 article in the UK 'Guardian', available at <http://www.theguardian.com/uk/2011/oct/30/metropolitan-police-mobile-phone-surveillance>, it is stated that a request for an export license by the Leeds based company 'Datong' was refused by BIS because it was judged that the potential transfer could facilitate human rights abuses.

In 2009 it was refused an export licence to ship technology worth £0.8m to an unnamed Asia Pacific country, after the Department for Business, Innovation and Skills judged it could be used to commit human rights abuses.

Can you please confirm under which specific category of the UK consolidated list the technology was required to have an export license? If possible, can you also confirm the description of the items?

Under the Freedom of Information Act 2000 ('the Act'), you have the right to:

- know whether we hold the information you require
- be provided with that information (subject to any exemptions under the Act which may apply).

I am writing to advise you that, following a search of our paper and electronic records, I have established that this Department holds information falling within scope of your request.

You ask us to "*confirm under which specific category of the UK consolidated list the technology was required to have an export license... (and)....also confirm the description of the items*". The attached spreadsheet includes details for two Standard Individual Export Licences (SIELs)

refused for Datong in 2009 including a summary description (Goods Annual Report Summary) and the rating of the goods for each licence.

Appeals Procedure


